2. The applicant(s) must inform **More Global Logistics Pty Ltd** in writing within seven (7) days of any change of his/her their business or corporate structure.
3. **More Global Logistics Pty Ltd** reserves the absolute right to refuse or withdraw the applicant(s) credit facilities at any time in the event that the applicant is in breach of these terms and conditions.
4. All contracts between **More Global Logistics Pty Ltd** and the Applicant shall be deemed to have been entered into in the State of Victoria and shall be construed according to the Laws of the State of Victoria.

  - (3) to keep or resell any goods repossessed pursuant to (2) above;
